"Vienna World Conference 30 Years On: Our Rights – Our Future"

Protecting human rights for our shared humanity

2023 marks the 30th anniversary of the World Conference on Human Rights, which took place in Vienna, Austria in 1993. Building on the Universal Declaration of Human Rights (UDHR) of 1948, the World Conference affirmed the universality and indivisibility of human rights. A pivotal moment, the conference's main outcome were the Vienna Declaration and Programme of Action (VDPA), a common plan for the strengthening of human rights work, which former UN Secretary-General Boutros-Ghali described as a "new vision for global action in human rights protection", as well as the establishment of the Office of the High Commissioner for Human Rights.

30 years after the adoption of the VDPA, our commitment to address human rights challenges is more important than ever. In spite of major achievements, multiple and interlocking crises keep fulfilment of the Universal Declaration of Human Rights on the horizon, with human rights often being deployed to justify divisions. In addition, new important aspects have emerged, such as globalization, digitization and climate change. Yet, without realizing human rights, there can be no lasting peace and no lasting security.

In order to address these concerns and to ensure that human rights are considered as part of the solution to the challenges we face, we need to restore faith and certainty in their relevance and necessity. We need to renew our understanding of the achievements of the VDPA, to revitalise a worldwide consensus on human rights and provide a platform for young people to exchange their ideas and plans on how to strengthen human rights in the future.

The Federal Ministry for European and International Affairs of the Republic of Austria in cooperation with OHCHR is organising a high-level human rights symposium on 6 June 2023 in Vienna, Austria. At this event, human rights stakeholders from diverse back-grounds will discuss current and future challenges and best practices in the promotion and protection of human rights. A synthesis of this discussion will be submitted as the Austrian contribution to the 75th anniversary year.

Young people will play an integral role in the Vienna +30 panel discussion, through a special event on 5 June with United Nations Special Rapporteur on the situation of human rights defenders Mary Lawlor, dedicated to young human rights defenders.

Vienna Youth Human Rights Defenders Conference 2023 Draft Programme

The year 2023 also marks the 25th anniversary of the adoption of the UN Declaration on Human Rights Defenders, which for the first time recognised the specific right to defend human rights. On this occasion, the UN Special Rapporteur on Human Rights Defenders Mary Lawlor and the Austrian Ministry for European and International Affairs will host a one-day conference in Vienna for youth and children human rights defenders. Up to 40 human rights defenders at-risk under the age of 32 are invited to participate.



A one-day gathering is to include panel discussions with young defenders and breakout meetings to address themes including the climate crisis, bullying, and LGBTIQ+ issues. Defenders will assess past and present victories and discuss how to respond to future challenges.



IN SOLIDARITY & HOPE

The objective of the conference is to recognize and encourage the work of young human rights defenders, provide a platform for collaboration, exchange and solidarity-building and identify the age-specific risks faced by young human rights defenders with a view to informing governments and multi-lateral actors how they might be better protected. There will also be a session involving Austrian civil society.
